BILL TO AMEND THE STATE AND LOCAL GOVERNMENT AUDIT LAW NO. 08, 2021

LAW NO. ¹⁰..... 2021

Enactment

The Zamfara State House of Assembly enacts as follows:

Citation

1. This law may be cited as the State and Local Governments Audit (Amendment) Law 2021 (1443 A.H).

Commencement

2. This law shall come into open action on the ^{5th} day of ^{Nov} 2021 (1443 A.H).

Amendment of Section of
Local Government
Audit Law no. 2021

3. The State and Local Government Law No ⁸ 2021 (in this law referred to as the principal law) is amended as set out in this law.

Amendment of Section 5(4)
of the Principle Law

4. Section 5(4) of the principal law is amended by substituting for the existing sub-section, a new sub-section as follows:

"5(4) the vacancy shall be filled by the appointment of the most qualified person with cognate experience in the public or private sector".

Amendment of
Section 10 (4)

5. Section 10(4) of the principal law is amended by complete deletion of the words *"recommend to the state civil service such member of staff for promotion"* immediately after the words *"Auditor General shall....."*; and be substituted in with the words *"shall promote such staff and forward same to state civil service Commission for issuance of the notification of promotion thereof"*.

Amendment of Section
10(5) of the Principal
Law

6. Section 10 (5) of the principal law is amended by complete deletion of the subsection and renumbering of the subsections therein.

Amendment of Section
10(6) of the Principal
Law

7. Section 10 (6) of the principle law is amended by substituting the word "Board" at the last paragraph of the section with the word "Service".

Amendment of Section
11(3) of the Principal
Law

8. Section 11 (3) of the principal Law is amended by substituting for the existing sub-section a new sub-section as follows;

"11 (3) notwithstanding anything contained in the State scheme of Service or any other enactment, the Auditors General may where deem necessary restructure the office and/or Departments of the Auditor General Office".

Amendment of Section
13 of the Principal Law

9. Section 13 of the principal law is amended;

In sub-section (1) by substituting the words *"Auditor General LGs"* with *"Auditors General"*.

In sub-section (3) by substituting the words *"Auditor General LGs"* with *"Auditors General"*.


