LAW NO 2023.

Preamble

WHEREAS under sections 120 and 121 of the Constitution of the Federal Republic of Nigeria, 1999 (As Amended) the Governor shall cause to be prepared and laid before the House of Assembly, a Law to cover the amount to be appropriated by the Appropriation Law.

Enactment

AND WHEREAS the head of expenditure contained in the estimates, other than expenditure charged upon the Consolidated Revenue Fund of the State shall be included in a Law to be known as the Appropriation Law, providing issue from the Consolidated Revenue Fund of the State sums necessary to meet the expenditure and the appropriation of those sums for the purpose specified therein.

The Zamfara State House of Assembly enacts as follows -

Short title and commencement

- This Law may be cited as Appropriation Law 2024 and shall come into operation on the 1st day of January 2024. (1445)
- Interpretation 2. In this Law -

"Accountant General" means the Accountant General of the State.

"Appropriation Law" means the Appropriation enacted under section 120 and section 121 of the Constitution of the Federal Republic of Nigeria, 1999 (As Amended) to cover the estimates and expenditure for the year ending 31st December, 2024.

"Capital Expenditure" means money set aside in the year 2024 Budget of Zamfara State for the execution of Capital Projects.

"Governor" means the Governor of the State.

"Recurrent Expenditure" means monthly running cost of the Ministries, Parastatals and Agencies for the payment of Personnel Cost, Overhead Cost, Consolidated Revenue Fund Charges and Internal Debts Services.

"Subvention" means salaries and overhead costs of parastatals and Agencies.

"State" means Zamfara State of Nigeria.

Expenditure of N N426,563,671,000.00)

- The Accountant General of the State may when authorized to do (1) so by warrant signed by the Commissioner for Finance, pay out of the Consolidated Revenue Fund of the State during the year ending 31st December, 2024 the sums specified by warrant, not exceeding in the aggregate FOUR HUNDRED AND TWENTY SIX BILLION ,FIVE HUNDRED AND SIXTY THREE MILLION, SIX HUNDRED AND NAIRA **THOUSAND** SEVENTY ONE (¥426,563,671,000.00) ONLY.
- The Sum of FOUR HUNDRED AND TWENTY SIX (2) HUNDRED AND SIXTY THREE BILLION, FIVE MILLION, SIX HUNDRED AND SEVENTY ONE THOUSAND NAIRA (\$426,563,671,000.00) ONLY, is now to be appropriated from the Consolidated Revenue Funds of the State to Cover One Hundred and Eighteen Billion, Three Hundred and Fifty-eight Million,

Seventy-nine Thousand, Five Hundred and Fifteen Naira (N118,358,079,515.00) Only and Three Hundred and Eight Billion, Two Hundred and Five Million, Five Hundred and Ninety-one Thousand, Four Hundred and Eighty-five Naira (N308,205,591,485.00) as recurrent and Capital Expenditure respectively.

(3) The said sum shall be deemed to have been appropriated for the purpose and in the manner expressed in the schedules to this Law.
