**IMPLEMENTATION OF COVID-19 PANDEMIC TAX RELIEF
PACKAGE GUIDELINES**

Sequel to the approval gave by His Excellency, the Executive Governor Dr. Bello Muhammad (Matawallen Maradun) for the relief to tax payers under the State to mitigate the impact of covid-19 pandemic. The following are the guide lines to be adopted:-


GENERAL GUIDELINES.

1. To issue internal memo for the implementation of the relief with effect from 1st July 2020 to 30th June 2021.
 - i. To all Directors and Deputy Directors.
 - ii. To all Zonal Revenue Officers.
2. To communicate with the taxpayers through various means of Communication/Media houses (Radio and TV stations) on how to enjoy the relief granted to them as a result of the Covid-19 pandemic.
3. To organised workshops to all staff of the board, for proper implementation of the relief.
4. All notice for the payment should clearly indicate relief waiver granted for the relevant categories of payments as approved.
5. 50% waiver of penalty and interest rate charged for under deductions and late remittance granted to all tax payers from 1st July, 2020 to 31st December, 2020.
6. All business premises registrations and renewals for Small, Medium Enterprises (SME) are to enjoy 100% waiver due to covid-19 pandemic.
7. All new tax rate for fine, fees and levies has been suspended for implementation within 1st July, 2020 to 30th June, 2021.

All correspondences to be addressed to the Executive Chairman

8. To operate a covid-19 tax relief package register at the Head Quarter and Zonal offices containing assessment and relief Colum to ensure all concern taxpayer benefited from the relief and amount waived are ascertained.
9. Tax operation department is to ensure proper monitoring and evaluation on daily and weekly basis to ascertain the implementation of the guidelines.
10. Continuation of airing the tax relief package jungles through radio and TV stations in the state throughout the specified period.
