Preamble

WHEREAS under sections 120 and 121 of the Constitution of the Federal Republic of Nigeria, 1999 (As Amended) the Governor shall cause to be prepared and laid before the House of Assembly, a Law to cover the amount to be appropriated by the Appropriation Law.

AND WHEREAS the head of expenditure contained in the estimates, other than expenditure charged upon the Consolidated Revenue Fund of the State shall be included in a Law to be known as the Appropriation Law, providing issue from the Consolidated Revenue Fund of the State sums necessary to meet the expenditure and the appropriation of those sums for the purpose specified therein.

Enactment The Zamfara State House of Assembly enacts as follows:

Short title and 1. commencement

This Law may be cited as Supplementary Appropriation Law, and shall come into operation on **8**th day of **December**, 2022 (1444 A.H).

Interpretation 2. In this Law unless the context otherwise requires:

"Accountant General" means the Accountant General of the State.

"Appropriation Law" means the Appropriation enacted under section 120 and section 121 of the Constitution of the Federal Republic of Nigeria, 1999 (As Amended) to cover the estimates and expenditure for the year ending 31st December, 2022.

"Capital Expenditure" means money set aside in the year 2022 Budget of Zamfara State for the execution of Capital Projects.

"Recurrent Expenditure" means monthly running cost of the Ministries, Parastatals and Agencies for the payment of Personnel Cost, Overhead Cost, Consolidated Revenue Fund Charges and Internal Debts Services.

"Governor" means the Governor of the State.

"**Subvention**" means salaries and overhead costs of parastatals and agencies.

"Supplementary Appropriation Law" means the appropriation enacted by the Zamfara State House of Assembly for the review of the Zamfara State Appropriation Law 2022.

"State" means Zamfara State of Nigeria.

Expenditure of 3. N133,953,435,000.00

(1) The Accountant General of the State may when authorized to do so by warrant signed by the Commissioner for Finance, pay out of the Consolidated Revenue Fund of the State during the year ending 31st December, 2022 the sums specified by warrant, not exceeding in the aggregate *One Hundred and Thirty Three Billion, Nine Hundred and Fifty Three Million, Four Hundred and Thirty Five Thousand Naira* (N133,953,435,000.00) Only.

 - (3) The said sum shall be deemed to have been appropriated for the purpose and in the manner expressed in the schedules attached to this Law.
