

COMMERCIAL PROPERTY REGISTRATION GUIDELINES (ORGANIZATION)

In Accordance with the provisions of 'Zamfara State Geographic Information System Agency Establishment Law, 2019".

1. Obtain the Right of Occupancy Organization Form (ROO) from:

All application forms (https://accountantgeneral.zm.gov.ng/images/documents/zagislandapplicationstatutor vrightoccupancyorganisation.pdf) are free. Fill out the form completely and accurately. Leave NO section empty or unanswered.

- 2. Gather copies of all relevant land documents. Originals are preferred. You are advised to have photocopies made for safekeeping. An Applicant may appoint someone to represent them at ZAGIS. The Representative of the Applicant shall fill the "Authorized Representative Column" in the Application Form.
- 3. Applicants are required to come with the following Documents for Application for C of O:
 - Corporate Seal;
 - Corporate Affairs Commission Certificate of Incorporation/Registration;
 - Photo ID: National ID Card or International Passport or Driver's License or Voter's Card of the CEO or a Director;
 - Land Transfer Documents such as Sales Agreement or Deed of Transfer or Inheritance Document;
 - Survey Plan (Original copy);

- Evidence of Personal Income Tax or Current Tax Clearance Certificate.
 Applicants can visit Zamfara State Internal Revenue Service or using this link to register http://zirs.zm.gov.ng;
- Utility Bill to verify Applicant's Home Address;
- Court Affidavit and Police Report for lost or stolen documents; and
- If Using an Authorized Representative, a signed letter is required.

Applicants will be given a customized Bank Teller through which they can then proceed to Zenith Bank to make payment of a one-time, non-refundable deposit of Zone A, Zone B, and Zone C Areas of N100,000.00, N70,000.00 and N50,000.00, respectively, as Prime Charge (Processing Fee). Other fees (https://accountantgeneral.zm.gov.ng/images/documents/zamfarageographicinformationsystemscheduleofpayment.pdf), such as the Premium and Current Ground Rent will also be charged but will be given at the Offer stage. All charges and fees are payable to ZAGIS Zenith Bank Account Number 1215565506. These payments are in line with Sections 25 to 33 of Zamfara State Geographic Information System Agency Establishment Law, 2019".

All documents as in (3) above must be submitted to the ZAGIS Customer Service Centre along with a Bank Teller/ Bank print-out for the specific prime charge(s)or mailed to ZAGIS Office at Olusegun Obasanjo Drive Adjacent to J.B. Yakubu Secretariat Gusau, Zamfara State.

- 4. Upon submission of complete documents listed in (3) above, the Applicants' shall be cleared within seven (7) working days from the date of submission.
- 5. Applicants whose documents have been cleared by the Geometry Unit will receive an Acknowledgement Letter, while Applicants whose documents aren't cleared will be issued an Incomplete Application Notice within three (3) working days telling them of the affected document(s) to be rectified.
- 6. All successful Applicants will be given a Bill for Ground Rent, Premium and Development Levy (https://accountantgeneral.zm.gov.ng/images/documents/zamfarageographicinformationsystemscheduleofpayment.pdf), and an Acceptance Letter within seven (7) working days, unless a Plot Identification/Inspection is needed.

- 7. In the event that plot identification/inspection is needed, ZAGIS team of inspectors will inspect the Plot within fourteen (14) working days after payment has been made and verified. The payment will be verified within two (2) working days.
- 8. Return your signed Acceptance Letter with evidence of payment of all fees to ZAGIS.
- 9. Successful Applicants will be notified by phone and or by email when their Certificates of Occupancy are ready for collection. All collections shall be at the ZAGIS Customer Service Centre within the hours of 9am and 4pm; Monday to Friday (excluding (pubic holidays). We are committed to a twenty (20) working day processing period after plot inspection in step 7 above and after all Fees and Charges are paid. Contact the ZAGIS Customer Service Centre if you have not received your collection notification after 30 working days.
