**PROCEDURE FOR OBTAINING PERMISSION TO LAY/ALTER/EXTEND A  
PRIVATE WATER SUPPLY SERVICE FOR INDIVIDUALS & BUSINESSES**

**Guiding Laws & Regulation**

*Section 196 of the Constitution of the Federal Republic of Nigeria, 1999 as amended and Zamfara State Consolidated Revenue Law, 2020.*

*All individuals and businesses seeking to obtain approval to connect to public water supply in Zamfara State can apply through the following process;*

**Step 1**

**Purchase application form at the cost of N1,000.00 for:**

**New Water Supply Connection Registration**

### Step 3

#### Submit all relevant documents

- The applicant proceeds to pay the designated fees (<https://accountantgeneral.zm.gov.ng/images/documents/waterboardconnectionpermitandotherfees.pdf>) into Zamfara State Water Board Account Number: **1014556015** with Zenith Bank Plc.
- Submit the duly completed Registration form directly to the Commercial Department of the Board.

#### Confirmation of Application:

- Upon registering, applicants will instantly be issued a Revenue Receipt after payment confirmation.
- Payment is confirmed within two (2) working days from the date of submission of the payment teller.
- With a payment receipt, applicants should proceed to Zamfara State Water Board located at Dan Sadau Road, Gusau, Zamfara State for water connection

#### Processing Timeline

- Timeframe for processing submitted applications **within 48 hours** prior to the final stage for collection described in step 4 below

### Step 4

#### Approval to connect to public water supply

- Successful applicants are issued Water Connection Certificate (WCC) immediately after Inspection within **48 hours** by the Board.
