## Guiding Law(s) & Regulation

Zamfara State Consolidated Revenue Law, 2020.

All individuals and organizations seeking to obtain Vehicle Inspection Certificate (VIC) from Zamfara State can apply through the following process;

	✓ Go to any Bank for payment through pay direct or e-bills within and outside Zamfara State.

	together with all relevant documents detailed in <b>Step 2</b> above.

#### **Confirmation of Application:**

- o Upon registering, applicants will instantly be issued a General Motor Receipt (GMR).
- Upon receipt of GMR, applicants should proceed for vehicle inspection at Vehicle Inspection Office, Sokoto Road, Near NNPC Deport, Gusau, Zamfara State.

#### **Processing Timeline**

• Submitted applications are processed **within 24 hours** prior to the final stage for collection described in step 4 below.

## Step 4

### Approval of Road Worthiness Certificate (RWC)

• Successful applicants are issued Road Worthiness Certificate (RWC) immediately after Inspection within 48 hours by the Vehicle Inspection Office, Sokoto Road, Near NNPC Deport, Gusau, Zamfara State.
