

#### Foreword

In the midst of our journey in the first and second quarters of the year, the coronavirus disease appeared in Asia gradually became a global pandemic. The global fight against the deadly virus led to the shutting down of the economies of the leading industrialized countries as a result of which oil demand declined worldwide, thus collapsing the market of the commodity.

This unprecedented dire situation led to depression such as the world witnessed in the 1930s, characterized by massive purges in industries, expansion of furlough system, and increased poverty most especially in the Globally. Nigeria and many countries are currently experiencing several of economic difficulties. Nigeria is currently in recession.

For this reason the state has to trim down 2020 budget to N127, 333,400,000 from earlier the original 2020 Approved budget N188, 549,559,140. In a bid to make citizens and other interest groups well-informed about the 2020 revised Budget of Zamfara State, Ministry of Budget and Economic Planning came up with this simplified presentation of the budget in a summarized form for easy understanding.

Zamfara State Fiscal Transparency Initiative (FTI) is part of the Public Expenditure and Financial Management Reforms of the State Government aimed at keeping the citizens informed. Citizens and other interest groups are informed of Government's fiscal plans which in away empowering them to constructively participate and contribute to the socioeconomic development and governance process of the State.



#### Zamfara State 2020 Approved Revised Revenue

The projections of all revenues largely take cue from actual collection of the preceding year. Other parameters are also taken into cognizance in the projection of the revenue. The Approved Recurrent Revenue was projected to N75,573,300,017 while Capital Revenue stood at N51,760,099,984. The State experienced revenues challenges on account of the shortfalls of accruals from Federation Account.



#### ZAMFARA STATE 2020 REVISED RECURRENT REVENUE




The state government for the Revised 2020 fiscal year has projected the sum of N31,200,000,000.00 billion as Statutory allocation from the Federal Government, while its Internally Genera ted Revenue amounted to N15,940,264,254.00 billion. and N28,433,035,762.00 billion from other federation account serves as recurrent revenue.



#### **RECURRENT EXPENDITUE**

For 2020 fiscal year review the State Government approve N58,315,399,999 as recurrent expenditure. This comprise of N22,179,452,687 as personnel cost, N24,168,345,966 as Over Head Cost, while Consolidated Revenue Funds Charges and Debt Service stood at N4,541,816,488, N7,425,784,858 respectively, as shown in the table below:




#### **CAPITAL EXPENDITURE**

The 2020 Revised Budget was largely focused on capital development with capital expenditure of N69,018,000,000 out the state budget size of N127,333AO0,000, the budget has no doubt will accelerated the rate of project implementation during the year couple with increased in demand for road construction. 




